Equine Release and Hold Harmless Agreement

WARNING

Pursuant to the Colorado Equine Activity Liability Act, Under Colorado Law, an equine professional is not liable for an injury to or the death of a participant in activities resulting from the inherent risks of equine activities, pursuant to section 13-21-119 of the Colorado Revised Statutes. In addition to posting of warning signs as required by said act, you, for yourself or as the parent/legal guardian for the below named minor child are hereby notified accordingly that Free Reins Equine LLC (from hereon, Free Reins Equine) and Brittany Hemric, are engaged in equestrian and other equine related activities. The very nature of equestrian and equine activities involves inherent risk and potential injury or even death to the participant. I acknowledge these risks and potential risks.

I feel that the possible benefits to me are greater than the risks assumed. I hereby grant permission and authority to Free Reins Equine LLC (from hereon, Free Reins Equine) and those acting on its behalf to obtain prompt medical attention in the event, I may become injured. Should medical treatment be required during or following my participation in an activity associated with Free Reins Equine, I agree that my insurance company shall pay for any and all expenses related thereto.

In consideration of Free Reins Equine allowing the participant to participate in this activity, I, on behalf of the participant, myself, the participant's and/or my heirs, personal representatives, and assigns, hereby agree to hold harmless, release and discharge Free Reins Equine, its employees, directors, and anyone associated, either directly or indirectly, with Free Reins Equine from any and all claims, demands, causes of action, and liability, whether the same be known or unknown, anticipated or unanticipated, due to Free Reins Equine and its representatives' ordinary negligence. I further agree, except in the event of Free Reins Equine gross negligence or willful misconduct, that I will not bring any claim or legal action against Free Reins Equine, its employees, directors, or anyone associated with Free Reins Equine.

I acknowledge that horses may react unpredictably to conditions, including, but not limited to, a sudden movement, loud noise, an unfamiliar environment, or the introduction of unfamiliar persons, animals, or objects. The horse also may react in a dangerous manner when a condition or treatment is considered hazardous to the welfare of the animal; a collision occurs with an object or animal; or a participant fails to exercise reasonable care, take adequate precautions, or use adequate control when engaging in a domesticated animal activity,

including failing to maintain reasonable control of the horse or failing to act in a manner consistent with the person's abilities

I represent that I am in good physical condition, and I am not aware of any disease or injury that would be aggravated or result in my being incapacitated or injury that would be aggravated or result in my being incapacitated or injured during any program participation except as designated herein.

There also are risks that I may take while leading, riding, feeding or otherwise interacting with horses. I also understand that I can help to minimize the risks by carefully following the direction of the staff. I understand that activities involving horses carry inherent risks and can be potentially dangerous despite all safety precautions. A horse may behave in a manner that result in damages to property or an injury or death to a person. Risks associated with the activity may include but are not limited to injuries caused by bucking, biting, stumbling, rearing, trampling, scratching, falling, or butting.

The terms of this agreement shall be construed as the entire agreement and may not be altered, amended or modified except in writing and signed by both parties. This agreement shall be governed by the laws of the state of Colorado and shall remain in effect for each activity with Free Reins Equine.
